This paper summarises measures we are adding to the measure set for He Ara Āwhina monitoring in 2024/25.

We first developed a measure set to monitor against He Ara Āwhina framework in late 2022. Since then, we have made various adjustments to the measure set.

This short paper outlines additions we have made to He Ara Āwhina measure set in 2024/25 (no measures were discontinued in this iteration).

With the additions, He Ara Āwhina measure set consists of 76 measures which data will be reported against in our <u>online dashboard</u>.

Background

He Ara Āwhina (HAĀ) framework shows what a good mental health and addiction system looks like for tāngata whaiora and whānau. We use He Ara Āwhina framework to monitor mental health and addiction services and system, using a broad measure set.

The HAĀ measure set was initially compiled in late 2022 - more information is available <u>here</u>. We used the HAĀ measure set for the first time in our 2023 monitoring report <u>Te Huringa Tuarua</u> and first release of the online HAĀ dashboard.

In 2024, we reviewed the HAĀ measure set to create a second version. In doing so, we removed 18 measures used in our 2023 monitoring. Further detail about the discontinued measures is available here. This second version of the HAĀ measure set was used in our 2024 monitoring report Kua Tīmata Te Haerenga and second release of the online HAĀ dashboard.

Added measures

In 2024/25, we undertook work to refresh the measure set and added 18 measures. Some of these measures we had previously used in focus reports, and we carried over into the core measure set. The added measures include:
